



PRIVACY POLICY

At Jus' Jah Magazine, we are committed to preserving and safeguarding the privacy of all visitors to our site.

This Privacy Policy explains what happens to any info that we collect from you or any personal data you provide to us while you visit our website.

On occasions we do update this Policy so please check it frequently.

Information We Collect

In maintaining and running our website, we may process and collect the following data about you:

- Information about your use of our site (pages viewed, resources you access, location data, communication data and traffic data).
- Information that you provide when you communicate with us.
- Information provided voluntarily by you. (For example, when you sign up to our newsletter or purchase any of our products/services).

Use of Cookies

Cookies provide information regarding the computer used by a visitor.

We may use cookies where appropriate to gather information about your computer to help us improve our website.

We may gather information about your general internet use by using the cookie. Where used, these cookies are downloaded to your computer and stored on the computer's hard drive.



Such information will not identify you personally. It is statistical data; this data does not identify any of your personal details.

You can adjust the settings on your computer to decline any cookies if you want to.

Our advertisers may also use cookies, over which we have no control. Such cookies (if used) would be downloaded once you click on advertisements on our website.

Use of Your Information

We use the information that we collect from you to provide our products and services to you. In addition to this, we may use the information for the following purposes:

- To provide information to you that you request from us relating to our products or services.
- If you have previously purchased goods or services from us, we may provide to you details of similar goods or services, or other goods and services, that you may be interested in.
- To provide information to you relating to other products that may be of interest to you. Such additional information will only be provided where you have consented to receive such information.
- Where your consent has been provided in advance, we may allow selected third parties to use your data to enable them to provide you with information regarding unrelated goods and services which we believe may interest you. Where such consent has been provided, it can be withdrawn by you at any time.
- To inform you of any changes to our website, services or goods and products.



Storing Your Personal Data

In operating the Jus' Jah Magazine website, it may become necessary to transfer data that we collect from you to locations outside of the European Union for processing and storing. By providing your personal data to us, you agree to this transfer, processing or storing. We will do our utmost to ensure that all reasonable steps are taken to make sure that your data is treated and stored securely.
